

# **Strathfield Council Strathfield Park Community Consultation**

## **Terms and Conditions**

1. Entry into the prize draw is deemed acceptance to these terms and conditions.
2. Entry is open to all persons who complete a Strathfield Park Community Survey from Strathfield Municipal Council (hereafter 'Council') via online and/or print copy, on or before 5pm on Friday 2 October 2020 ('the prize').

4. Councillors and Council employees and their immediate families are not eligible to enter.
5. The winner will be selected using the following process. All completed surveys that have entered the draw will be selected using a randomised electronic formula.

The winner will be notified by mail and/or telephone and may be published on Council's website: [www.strathfield.nsw.gov.au](http://www.strathfield.nsw.gov.au).

The Promoter ("Council") reserves the right to disqualify any entry that is not in accordance with these Terms and Conditions or who has, in the opinion of Council, engaged in conduct in entering the draw which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of Council. Council reserves the right to disqualify a winner if Council becomes aware that the winner and/or the winner's entry is of a type described in this clause.
8. Council accepts no responsibility for any late or misdirected registrations due to technical disruptions, network congestion or for any other reason.
9. Each winner will receive one (1) shopping voucher valued at \$50.
