

Amendments to draft Plans of Management

A number of draft plans were previously exhibited. The following amendments have been made to these plans.

General changes (applies to all draft plans of management)

- Land categorisation maps reformatted – no change to proposed categorisations content except Bark Huts Reserve where land for park was increased to provide buffer space adjoining Maria Reserve, a natural area (bushland).
- Updated current population figures and minor corrections (s.2.2)
- Updated vision to include reference to Local Strategic Planning Statement, which was adopted after the plan of management exhibition but directly references plans (s.2.4)
- A section on legislative and policy framework added to each draft plan (s.2.5)
- Added information on permissible uses and development (s.4.1)
- Added additional actions to natural environment targets (s.5.1)

Draft Bark Huts Reserve Plan of Management

- Land covered by Park categorisation extended at the boundary of Maria Reserve to provide for transition or buffer between parkland and natural area (bushland)

- Added environmental features clauses including reference to transition areas and relationship of land to Maria Reserve Bushland and Green and Golden Bellfrog.
