



# BRESSINGTON PARK COMMUNITY CONSULTATION PLAN OF MANAGEMENT

Bressington Park is one of the Strathfield Council area's largest parks. It is located on Underwood Road, bounded by Homebush Bay Drive and Powells Creek, and opposite DFO. The park offers a wide range of sporting, community and recreational facilities.

## New Bressington Park Plan of Management

Bressington Park is made up of Crown Land and Council land. The park is managed by Strathfield Council. Crown Land is land owned by the NSW Government dedicated for community use. Due to changes to legislation, community engagement is required in the preparation of new plans of management. The new plan will guide the park's future management and development, informed from consultations with the local community.

## What facilities are available in Bressington Park?

Bressington Park contains a wide range of community and recreation facilities including sportsfields, playgrounds, amenities and areas of open space. The key features of the park include:

- Five sportsfields
- Four synthetic cricket wickets
- Two cricket practice wickets
- Off-leash area for dogs
- 2 playgrounds
- Parklands containing shelters, seating and BBQ areas
- Open grassed areas and revegetated indigenous trees and plantings throughout the park
- Amenities eg toilets, change rooms, kiosk
- Carpark
- Bay to Bay cycle/pathways linking the park from the south to the north of the Strathfield Council area and to regional destinations such as Botany Bay, Sydney Olympic Park and Ryde.



## What is the process for preparing these plans?

Once the initial community consultation is complete, all feedback and suggestions from the community and park users will be compiled and assessed, and will inform the new plans.

Once the draft plans are prepared, the community will have the opportunity to make comments during the public exhibition period. Council will consider all submissions received during the time for inclusion in the final plans as well as consult with NSW Crown Lands. Once the final plans are prepared, they will be presented to a Council meeting for adoption.
