### 6.1 Barker Road, Strathfield - Change to No Stopping

The resident of 20 Barker Road, Strathfield requested that the existing No Stopping zone on the southern side of Barker Road, west of Wallis Avenue be reduced in length to allow additional onstreet parking.

The existing No Stopping sign located on the southern side of Barker Road is approximately 20m from the intersection of Wallis Avenue. This extended No Stopping zone was originally introduced to assist with vehicles egressing from the driveway at 20 Barker Road. With the kerb blister islands at the intersection of Wallis Avenue providing improved sight lines and protections, the resident of 20 Barker Road no longer requires the extended No Stopping zone. It is recommended that the No Stopping zone be shortened to 10m to retain the minimum statutory requirement.




Figure – Proposed Change to No Stopping

### 6.2 Rochester Street, Homebush - Parking Changes

Council has been approached by the business owners of Rochester Street between Burlington Road and Abbotsford Street, Homebush requesting for short-term parking restrictions to encourage parking turnovers.

The on-street parking in Rochester Street between Burlington Road and Abbotsford Road is restricted to 2 hours between either 10am and 4pm or 8am and 6pm, 7 days per week.



Figure 1 – Existing Parking Restrictions along Rochester Street

To determine appropriate parking restrictions, Council Officers spoke to all business owners on two occasions to gather their views. Whilst the majority of business owners expressed their preference over shorter parking restrictions (e.g. 1P), they also indicated that any restriction shorter than 1 hour would not provide enough visiting time for their customers. It is hence considered appropriate to change the parking restrictions in front of the shops to 1 hour. Given the previous concerns raised by the local residents for the lack of long-term parking in the area, it is recommended that the parking restrictions in front of the residential properties remain unchanged.




Figure 2 Proposed Parking Restrictions along Rochester Street

Council has also been requested to review the existing Kiss & Ride zone on the eastern side of Rochester Street between The Crescent and Burlington Road. The request is to reduce the Kiss & Ride zone to approximately 30m between the driveway and pedestrian crossing near Burlington Road instead of the entire 90m road section. Homebush Public School has been consulted and raised objection to any reduction in Kiss & Ride zone length or time duration. For reference, the original Kiss & Ride zone in Burlington Road prior to the Village Upgrade was approximately 55m in length. It is noted that the current Kiss & Ride zone already has a compressed time duration of 8:30-9:30am and 2:30-3:30pm on school days.

### 6.6 Shortland Avenue, Strathfield - Kiss and Ride Zone Extension




Figure 1 - Proposed Kiss & Ride Zone extension (existing shown in grey and extension shown in colour)

On January 15, 2021 St Patrick's College's new Science and Learning Building was approved under the State Significant Development Application (SSD-10400). As part of the SSD approval, the existing Kiss & Ride zone on Fraser Street and Edgar Street was required to be extended onto Shortland Avenue as shown in *Figure 1* below. The plan would provide approximately an additional 100m of Kiss & Ride zone along the School frontage on the southern side of Shortland Avenue. St Patrick's Collage now seeks Council approval for an earlier implementation of this Kiss & Ride zone extension which was only required prior to the issue of an Occupation Certificate under the SSD.



To satisfy the condition of consent, the consultant Urbis on behalf of St Patrick's College, carried out a community engagement campaign. The campaign was to:

- Provide accurate information about extended Kiss & Ride zone.
- · Create pathways for stakeholder interaction and feedback that are open and transparent.
- · Collect and document feedback to inform ongoing operations.

The full Engagement Outcomes Report is attached. The report outlines three steps undertaken to engage the community:

- On 15 May 2021, a notification was delivered to 347 properties surrounding the school to provide information about the Kiss & Ride zone, an update of the planning and construction process and contact information for further enquires.
- 2) On 18 May 2021, Urbis Engagement door knocked of 16 neighbouring residents on Shortland Avenue, Fraser Street and Edgar Street in Strathfield to supply information about the proposal and provide residents an opportunity to provide feedback.
- Members of the public were invited to contact St Patrick's College through a dedicated phone number and email address. Three people phoned or emailed to provide feedback or seek further information from 15 May to 27 May 2021."

Among all engagement feedback on various traffic and parking issues presented in *Table 1* of the Engagement Outcomes Report, the extension of the Kiss & Ride zone received positive sentiment overall. Council has since been approached by a resident who requested the Kiss & Ride zone extension to be relocated on the northern side of Shortland Avenue, in front of Kessell Square. Concerns were raised about the additional westbound traffic along Shortland Avenue associated with the Kiss & Ride zone extension. The School was contacted for additional clarification to be provided at the Traffic Committee. It is considered appropriate to support the early implementation of the Kiss & Ride zone extension which would allow parents to adapt to the changes and allow Council to re-assess the conditions and make changes as required prior to any construction works.

Issues raised about the construction traffic impacts are anticipated to be addressed by a detailed Construction Traffic and Pedestrian Management Plan (CTPMP) which is required as a condition of consent, to Council's satisfaction prior to the issue of a construction certificate. The School indicated that the preparation of the plan will commence after a construction contractor is engaged in due course.

Submission on this matter from a resident was tabled at the meeting.

### RECOMMENDATION

That

- Council approve the extension of the Kiss & Ride zone onto Shortland Avenue as per Figure 1.
- Council Officers notify the residents of the affected road section in Shortland Avenue, Fraser Street and Edgar Street of the parking changes prior to the implementation.
- The cost associated with the signposting is to be borne by the applicant.
- Council investigate further alternative ways of reducing car trips, e.g. remoted pick up/drop
  off locations away from the School served by school buses

### 6.7 Abbotsford Road, Homebush - Review of Traffic Conditions

Council has been approached by residents of Abbotsford Street raising concerns about the recent traffic changes in Abbotsford Road, as a result of the implementation of one-way in Burlington Road between Meredith Street and Homebush Road. The traffic changes in Abbotsford Road observed by residents are outlined below:

- Significantly more traffic at all times of the day.
- · Significantly more heavy vehicle movements, in particular during night times.
- Increased speed.
- Increased level of noise.
- Difficult to access driveways.
- Danger to pedestrians.

The residents have requested consideration to be given to the following treatment options:

- Close Abbotsford Road at both Homebush Road and Meredith Street ends to create a nothrough road.
- Or convert Abbotsford Road into one-way (same as Burlington Road for westbound only).
- And reduce the default speed limit from the current 50km/hr to 40km/hr.

In response to the requests, Council Officers organised 7-day on-site tube counts between 7 May and 13 May 2021. The tubes were placed at three selected mid-section locations. The average daily traffic (ADT) and commercial vehicle percentage at each count location are plotted in Figure 1.

The survey results suggest the following traffic conditions in Abbotsford Road:

- The eastbound traffic volumes are significantly higher than the westbound traffic. This is likely due to Burlington Road only permitting one-way westbound traffic.
- The commercial vehicle percentage is at a reasonable level for residential streets. However
  noting there is already an existing 3t truck ban on Abbotsford Road, there could be some
  illegal truck movements.
- The overnight traffic volumes are low. In particular the commercial vehicle movements are insignificant.
- There is a minor speeding issue between Meredith Street and Rochester Street.

The requested one-way or road closure options may improve the local amenity, they also require residents to detour which would result in additional circulating traffic and congestion in the area. One-way and road closure schemes often encourage vehicle speeding due to the reduced traffic volumes. It is considered more appropriate to introduce additional traffic calming devices e.g. speed cushions which would address speeding issues as well as deviate some rat-run traffic behaviours.

TfNSW is the authority to set the speed limits in NSW. The current speed limit system only warrants a 40km/h speed limit in approved school zones or high pedestrian activity areas. In terms of the speed limit reduction request, TfNSW has previously advised that residential streets in Homebush Village other than The Crescent and Rochester Street may not have sufficient pedestrian activity required to justify a High Pedestrian Activity Area (HPAA).







#### 6.10 High Street at Amaroo Avenue, Strathfield - Proposed Roundabout

A recent car collision at the intersection of Amaroo Avenue and High Streets has highlighted the need to investigate speeding and driver behaviour along both Amaroo Avenue and High Street.

A site investigation of the intersection identified that the sight distance for vehicles in Amaroo Avenue looking onto High Street was limited due to the existing trees, power pole and parked cars along High Street.

A survey conducted on 29 October 2020 found a high volume of vehicles along High Street (317) and Amaroo Avenue (63). The Count was conducted for a period of 90 minutes (8am to 9.30am).

High Street and Amaroo Avenue are local roads with a 50 kph speed limit. The intersection is controlled by GIVE WAY signs on both approaches of Amaroo Avenue and the associated line markings need to be updated.

Council Officers have prepared a preliminary design of a mountable roundabout at this intersection. The proposal will require kerb realignment and minimum loss of on street parking.


Figure: Preliminary Design of Mountable Roundabout





#### 6.1 The Crescent and Burlington Road, Homebush - Additional Traffic Calming

Council has received a request to install a speed hump on both Burlington Road and The Crescent, Homebush to reduce alleged vehicle speeding and improve safety. With the recently installed roundabouts at the intersection of The Crescent and Rochester Street and the intersection of Burlington Road and Rochester Street, concerns were raised about the approaching vehicle speed in the westbound direction at both intersections.

Traffic counts were undertaken in both The Crescent and Burlington Road, between 10 June and 16 June 2021, to investigate the alleged speeding issue. 40 km/h speed limit applies to The Crescent between Homebush Road and Subway Lane as part of the existing High Pedestrian Activity Area (HPAA). Burlington Road east of Rochester Street is part of a school zone where 40 km/h speed limit applies during school zone hours. Outside the school zone hours, the default speed limit of Burlington Road is 50km/h. The traffic counts indicate that the recorded westbound speeds on The Crescent and Burlington Road are under the speed limit. Three minor or moderate crashes were recorded at the intersection of The Crescent and Rochester Street between 2015 and 2019 prior to introducing the roundabout.

The recorded speeds indicated that the roundabout entry speed is almost equivalent to the road operational speed. This is likely due to the limited horizontal deflection as a result of the geometry constraints. To enhance safety, it is recommended additional vertical deflection, for example, a speed cushion to be introduced. The roundabouts with raised platforms on approach treatment has been recognised as well suited to low-speed urban environments ( $\leq$  60 km/h), in the recently published *Austroads Guide to Road Design Part 7 New and Emerging Treatments* for the following benefits:

- improved general safety through reduced impacts speeds
- · reduced space required compared to a traditional roundabout with horizontal deflection
- potential cost reductions




Figure 4 – Proposed Speed Cushion and the Associated Signs on Burlington Road




Figure 3 – Proposed Changes to Park Road at Derowie Avenue

A proposal to install rubber speed cushions at the indicated locations on The Crescent and Burlington Road is presented in Figures 3 and Figure 4. The speed cushion shall be no greater than 1.6m wide to comply with the State Transit Bus Infrastructure Guide.

#### 6.2 Park Road, Homebush - Review of On-street Parking

Pursuant to Traffic Committee Meeting dated 15 June 2021, Council Officers investigated the feasibility of providing additional parking on Park Road.

This section of Park Road is a two-way local road with a cul-de-sac at its western end. Unrestricted kerbside parking is generally permitted on both sides of the road except for the sections adjacent to the medians. The raised median treatment reduces vehicle speeds by narrowing the road and prevents head-on collisions by separating opposing traffic. Council has been requested to investigate the feasibility of removing the medians to allow more on-street parking in Park Road, as a result of a recent proposal of removing on-street parking in Kanoona Avenue and Derowie Avenue nearby.




Figure 2 – Street View of the Road Section Under Assessment

An assessment revealed that Park Road is 10m wide kerb to kerb. The carriageway can adequately accommodate 2m wide kerbside parking and 3m wide trafficable lane in each direction in general. Where medians exit, it is considered feasible to demolish the median to allow additional on-street parking. The installation of 10m statutory No Stopping and BB lines is proposed at both intersections to regulate turning movements and maintain sight lines. The changes would increase the on-street parking (as hatched in blue in Figures 2 and 3) by approximately 150m (27 spaces) overall. For reference, the previous proposal of removing kerbside parking from Kanoona Avenue and Derowie Avenue affects approximately 150m kerbside parking in total. The proposed changes in Park Road would compensate entirely the parking loss in Kanoona Avenue and Derowie Avenue. Whilst the physical road narrowing is to be removed, reinstating on-street parking would provide alternative traffic calming benefits and create a self-enforced low speed environment.

#### 6.3 Richmond Road, Homebush West - Proposed Parking Changes for EV Charging

Jolt Charge Pty Limited (the applicant) has lodged a Development Application (D.A.) for the installation of advertising signage panels on a proposed electric vehicle charging station, which is to be installed on an existing electricity substation kiosk outside 19 Richmond Road, Homebush West. As the proposed development cannot be realised without the approval of the associated EV Charge space on-street, the applicant is seeking approval from the Traffic Committee for dedicating an on-street parking space for EV charging at this location.

The request is to install approximately 7m of "No Parking (symbolic) Electric Vehicles Excepted Only While Charging" zone on the western side of Richmond Road, between the respective driveways at 21A Richmond Road and 19 Richmond Road. The zone is anticipated to be utilised mostly by electric passenger vehicles passing the area. This section of Richmond Road is a local road with 50 km/h speed limit. Unrestricted kerbside parking is permitted on both sides of Richmond Road.

Due to the late request, the Traffic Team has not been able to complete a public consultation on this traffic proposal to gather the views from the affected business owners or residents. Notwithstanding this, during the D.A. exhibition between 16 April 2021 and 30 April 2021, one (1) submission was received raising the following concerns:

- Potential impacts to on-street parking due to the EV charge station associated with the D.A.; and
- The implications to heavy vehicles entering and exiting 21A Richmond Road Homebush West due to the EV charge station associated with the subject D.A.

The proposal involves the dedication of one on-street parking space which is considered having an insignificant impact given the ample surrounding on-street parking supply. With increased EV uptake, this space may generate higher parking turnover than the current situation. With regards to the heavy vehicle access to 21A Richmond Road, it is noted that the space in question is already a legal on-street space with no previous report received on parked vehicles impeding vehicular access at this location. Council Officers have also contacted the representative of 21A Richmond Road seeking feedback. Comments received will be tabled at the meeting.

#### 6.4 Loftus Lane, Homebush - Temporary Full Road Closure

Decode Sydney Pty Ltd lodged an application for a temporary full road closure in Loftus Lane, Homebush.

As part of the construction works at 136-144 Parramatta Road, Decode plan to erect a 250 tonne hydraulic crane on the site. The tower crane will be transported in sections by semi-trailers and assembled from the site's rear frontage in Loftus Lane. Due to the size of the semi-trailers and restricted lane width in Loftus Lane, 3m wide emergency access cannot be maintained and the activities hence require a temporary full road closure of Loftus Lane. The work is scheduled between 7am and 7pm on Friday 20 August, 2021. The activities include 2 hours of assembly, 8 hours of lifting and 2 hours of dismantle.




Figure 1 – TCP 3715

Loftus Lane is to have resident access only during the full road closure. The site will provide appropriate signage in accordance with TCP 3715 to guide a traffic detour around the site. A TMP containing the traffic management measures are outlined below:

#### D. Assessment of Public Transport Services Affected

E. Details of Provision made for Emergency Vehicles, Heavy Vehicles, Cyclists and Pedestrians

Emergency vehicles will have no access through the site whilst the works are being performed, all emergency services will be notified prior to the commencement of works.

Heavy vehicles will also not have any access through the work site. Signage will be placed to notify drivers of Resident Access Only.

All pedestrians are to follow directions from qualified traffic controllers.

All Cyclists are to follow the same detour as vehicles.

#### F. Assessment of Effect on Existing and Future Developments with Transport Implications in the Vicinity of the Proposed Measures

The activities are limited at the site frontage and have no impact on existing or future developments in the vicinity.

#### G. Assessment of Effect of Proposed Measures on Traffic Movements in Adjoining Council Areas

#### H. Public Consultation Process

Yes, a minimum seven (7) days notification must be provided to adjoining property owners prior to the implementation of any temporary traffic control measure. A copy of the notification letter was provided.

#### 6.5 Abbotsford Road at Homebush Road, Homebush - Request for Roundabout

Council has received a request to introduce a roundabout at the intersection of Abbotsford Road and Homebush Road, Homebush, to assist with vehicle turning and improve intersection safety.

To address some previously raised safety concerns at this intersection, the Traffic Committee at its meeting dated 20 April 2021 already resolved that "Do Not Queue Across" sign (G9-237) and pavement marking are to be introduced at the intersection of Abbotsford Road and Homebush Road as per Figure 1. The treatment has yet to be fully implemented to allow an observation of its effectiveness.




Figure 2– Line Marking and Signage Treatments




Figure - Street View and Plan of Dalton Avenue



It is essential that any commercial or industrial developments along this corridor identify and incorporate water conservation and stormwater management measures, retain mature trees, preserve permeable surfaces and retain open green space.

Given an increase in commercial and residential high-density housing along the Cooks River Corridor, it is essential that Council apply strict water sensitive design principles to adverse impacts on the riparian zone. It is also essential that Council looks to retaining mature trees in this corridor as they provide:

- Vital cooling benefits in an area subject to the urban heat island effect
- Essential ground water filtration
- A decrease in flooding impacts in a flood zone
- Shade and amenity to the adjacent Cooks River public walkway
- A natural sound barrier
- A refuge and food source for native fauna

#### RECOMMENDATION

That a Water Sensitive Urban Design strategy be prepared for any commercial or industrial development which may result in a net loss of green space or mature trees along the Cooks River Corridor.

#### PURPOSE OF REPORT

To provide a progress report on the implementation of Council's Delivery Program 2018-2022.

#### REPORT

In accordance with the requirements of the NSW Office of Local Government's Integrated Planning and Reporting guidelines and Section 404 of the *Local Government Act 1993*, a progress report must be presented to Council on the principal activities in the Delivery Program every six months.

The current Community Strategic Plan – Strathfield 2030 and the Delivery Program 2018-2022 was adopted in June 2018. These programs and plans reflect the goals and strategies set out in the Strathfield Community Strategic Plan 'Strathfield 2030' under the five principal activities of Connectivity, Community Wellbeing, Civic Pride and Place Management, Liveable Neighbourhoods and Responsible Leadership.

The Delivery Program 2018-2022 contained four year objectives against each of the five principal themes. The Operational Plan 2019-2020 conveyed yearly actions and key performance indicators to detail the actions for the financial year to progress the Delivery Program.

The attached report provides a progress report of actions against the Delivery Program and capital works for the period January to June 2021.

This six-monthly report indicates actions to curtail the spread of COVID-19 virus continued to impact on the delivery of Council programs. In early 2021, many service and programs had restarted, albeit with some restrictions but in June 2021, Greater Sydney was put into lockdown due to increasing rates of COVD infection, which resulted again in closure of facilities, cessation of events and programs and delays in completing works such as the amenities building in Hudson Park.

Many capital works reached completion in the reporting period. Construction of the café and amenities in Strathfield Park commenced. Installation of outdoor fitness equipment at Ford Park, Freshwater Park, Dean Reserve and Airey Park and the informal pathway at Airey Park stage 1 was completed. A substantial amount of capital works reached completion including roads, footpaths, drainage and kerbs and guttering which is outlined in the attached report.

The annual Council performance survey was conducted in late 2020 and reported high levels of community satisfaction with Council services and facilities.

#### Delivery Program Report January to June 2021 (Cont'd)

The Annual Report will be published in November 2021 and will contain statutory reporting and achievement highlights of the 2020-2021 financial year.

Council has earned interest revenue totaling \$ 14,534.22 as at 31 July 2021, being 5.68% of the original projected budget.





# CS3 MAYORAL AND DEPUTY MAYORAL ELECTION

### RECOMMENDATION

- 1. That Council conduct the election of the Mayor and Deputy Mayor by open voting.
- 2. That Council elect the Mayor for the 2021 term from 14 September 2021 until 4 December 2021.
- 3. That Council elect the Deputy Mayor for the 2021 term from 14 September 2021 until 4 December 2021.
- 4. That the Returning Officer conduct the election in accordance with the *Local Government Act* 1993 and the *Local Government (General) Regulation 2005*.

# PURPOSE OF REPORT

To detail the procedures for the conduct of the election of the Mayor and Deputy Mayor for the 2021 term (length of term being from 14 September 2021 until 4 December 2021).

# REPORT

#### Election of Mayor

Section 282(2) of the *Local Government Act 1993* (the Act) provides that the Council shall elect one of its members to be Mayor.

#### Role of Mayor

Section 226 of the Act provides:

"The role of the mayor is as follows:

- (a) to be the leader of the council and a leader in the local community,
- (b) to advance community cohesion and promote civic awareness,
- (c) to be the principal member and spokesperson of the governing body, including representing the views of the council as to its local priorities,
- (d) to exercise, in cases of necessity, the policy-making functions of the governing body of the council between meetings of the council,
- (e) to preside at meetings of the council,

#### Mayoral and Deputy Mayoral Election (Cont'd)

- (f) to ensure that meetings of the council are conducted efficiently, effectively and in accordance with this Act,
- (g) to ensure the timely development and adoption of the strategic plans, programs and policies of the council,
- (h) to promote the effective and consistent implementation of the strategic plans, programs and policies of the council,
- (i) to promote partnerships between the council and key stakeholders,
- *(j)* to advise, consult with and provide strategic direction to the general manager in relation to the implementation of the strategic plans and policies of the council,
- (k) in conjunction with the general manager, to ensure adequate opportunities and mechanisms for engagement between the council and the local community,
- (I) to carry out the civic and ceremonial functions of the mayoral office,
- (*m*) to represent the council on regional organisations and at inter-governmental forums at regional, State and Commonwealth level,
- (n) in consultation with the councillors, to lead performance appraisals of the general manager,
- (o) to exercise any other functions of the council that the council determines"

#### Procedure for the Mayoral Election - Local Government (General) Regulation 2005 - Schedule 7

- a. The General Manager (or a person appointed by the general manager) is the Returning Officer.
- b. A councillor may be nominated without notice. The nomination is to be made in writing by two or more councillors, one of whom may be the nominee. Nomination forms can be obtained from the Returning Officer. The nomination is not valid unless the nominee has indicated consent to the nomination in writing.
- c. The nomination is to be delivered or sent to the Returning Officer.
- d. The Returning Officer is to announce the names of the nominees at the council meeting at which the election is to be held.
- e. If only one councillor is nominated, that councillor is elected.
- f. If more than one councillor is nominated, council must resolve whether the election is to proceed by:
  - (i) preferential ballot, or
  - (ii) ordinary ballot, or

### Mayoral and Deputy Mayoral Election (Cont'd)

- (iii) open voting.
- g. Preferential ballot and ordinary ballot will be secret ballots, open voting means voting by show of hands or similar means.
- h. If the election is to be held by ordinary or preferential ballot it shall be conducted by the preparation, marking and counting of the ballot papers in the presence of the Council. Clause 5 of Schedule 7 of the Regulation provides:

"If the election proceeds by ordinary ballot, the returning officer is to decide the manner in which votes are to be marked on the ballot papers."

(Usual practice is to place a one (1) in the square opposite the name of your favoured candidate).

- i. Clause 6 of Schedule 7 deals with an election involving two (2) candidates and provides:
  - (1) If there are only 2 candidates, the candidate with the higher number of votes is elected.
  - (2) If there are only 2 candidates and they are tied, the one elected is to be chosen by lot.

**NOTE:** To choose a candidate by lot, the names of the candidates who have equal numbers are written on similar slips of paper by the returning officer, the slips are folded by the returning officer so as to prevent the names being seen, the slips are mixed and one is drawn at random by the Returning Officer and the **candidate whose name is on the drawn slip is chosen** (Clause 12).

j. Clause 7 of Schedule 7 deals with an election involving three (3) or more candidates and provides:

Count – three (3) or more candidates

- (1) If there are 3 or more candidates, the one with the lowest number of votes is to be excluded.
- (2) If 3 or more candidates then remain, a further vote is to be taken of those candidates and the one with the lowest number of votes from that further vote is to be excluded.
- (3) If, after that, 3 or more candidates still remain, the procedure set out in subclause (2) is to be repeated until only 2 candidates remain.
- (4) A further vote is to be taken of the 2 remaining candidates.
- (5) Clause 6 of Schedule 7 then applies to the determination of the election as if the 2 remaining candidates had been the only candidates.
- (6) If at any stage during a count under subclause (1) or (2), 2 or more candidates are tied on the lowest number of votes, the one excluded is to be chosen by lot.
