## Nature Strip Maintenance Application Form

ATTENTION: ENGINEERING AND OPERATIONS

Application for regular nature strip maintenance must be made annual for each financial year commencing 1 July.

Strathfield Council may, at its discretion, agree to undertake maintenance of nature strip where special circumstances apply.

In order to determine eligibility to receive a nature strip maintenance service, a person must:

- 1. Be a ratepayer of Strathfield Council AND be a resident of the property.
- 2. Provide evidence of ill health, physical disability, medical condition or inability to maintain the nature strip in the form of a medical certificate.
- 3. Provide evident of financial hardship in the form of an age, disability or service pension.
- 4. Provide a Statutory Declaration stating that you do not have a gardener doing the internal maintenance of the lawns.
- 5. Provide a Statutory Declaration stating that there are no other members of the household who can assist.

Applicants must provide ALL forms of evidence for eligibility to be assessed.

**Please Note:** Applications are subject to review on an annual basis. As such, Council will request a new application to be submitted annually.
