

Protocol for Requesting CCTV Footage from Strathfield Council

Strathfield Council operates an Internet Protocol (IP) based CCTV camera network in town centres located in the Strathfield Local Government Area. The information contained in the footage recorded is collected for law enforcement purposes and shall only be disclosed to persons or bodies who have a legitimate and lawful right or interest in receiving such information.

The information is not disclosed for any unauthorised purpose nor is it disclosed to any person or body who does not have a legitimate and lawful right or interest in receiving the information. CCTV footage that contains personal information will only be disclosed by Strathfield Council for law enforcement purposes or as otherwise required or permitted at law. It is a condition of disclosure that such footage only be used for law enforcement purposes.

When footage is required by Police for review, all requests must be received in writing stating the time and date of the incident for approval and release of the relevant information on DVD, CD or USB, by the General Manager or his delegate. The requesting officer is to indicate the location of the incident and the relevant camera/location from which the footage would have been recorded.

All requests for information on DVD, CD or USB from Council's CCTV network in the Strathfield Council area must be received in writing.
