### PURPOSE OF THIS EXPRESSION OF INTEREST

Strathfield Council is seeking Expressions of Interest from applicants with a diverse background in a broad range of skills and experience to be the Council appointed members on the NSW Sydney Eastern City Planning Panel (SECPP).

Council is looking to appoint two members and one alternate member. Membership on the SECPP is for a period of up to three years.

The Sydney Eastern City Planning Panel has five members, consisting of three independent expert members, including the Chair, who are appointed by the Minister for Planning (State members), and two Council nominated members.

Sydney and Regional Planning Panels were introduced to NSW in 2009 to strengthen decision making on regionally significant development applications and other planning matters. The criteria for regionally significant development generally includes the following:

- Development that has a capital investment value of more than \$30 million.
- Council related development that has a capital investment value of more than \$5 million, where council is the applicant, owner, developer or party to an agreement relating to the development.
- Crown development that has a capital investment value of more than \$5 million.
- Some types of designated development, including extractive industries, marinas and waste management facilities.

Strathfield Council is a medium sized Council located in Sydney's Inner West. The Council covers the suburbs of Strathfield, Strathfield South, Homebush, Homebush West, Belfield (part) and Greenacre (part).

You are not eligible to apply if you are:

- A property developer (or a person who is a close associate of a property developer) within the meaning of section 96GB of the Election Funding, Expenditure and Disclosures Act 1981, or
- A real estate agent within the meaning of the Property, Stock and Business Agents Act 2002.

- Provision of a statutory declaration stating that the applicant's submission is true and accurate; the applicant is eligible to be a community representative and does not within one of the categories that prohibits membership as a community representative.
