#### 3 EOI Scope and Application Criteria

#### 3.1 Scope and Requirements

The Multicultural and Diversity Advisory Committee is a purely advisory committee to Council and has no decision-making authority and therefore cannot commit Council resources, direct employees of Council or deal with operational matters.

The Committee is looking for up to three (3) members of the community who are willing to engage in stakeholder networking and provide advice to Council on recommendations multicultural and diversity affecting the Strathfield LGA and provide advice on promoting cross cultural understanding and harmony as well provide input and ideas on key Council related events.

Other stakeholder or professional groups who have an interest in the Strathfield Local Government area and believe that they can positively contribute to the Committee are welcome to nominate a representative to participate in the Committee on the entities behalf.

Membership of the Committee is outlined in the Multicultural and Diversity Advisory Committee Terms of Reference (attachment 1).





The aims and objectives of Multicultural and Diversity Advisory Committee are:

- To provide a forum for raising issues affecting Strathfield's multicultural community generating appropriate responses from all sectors of the community to address such issues.
- To promote cross cultural understanding and harmony within the Strathfield Local Government Area (LGA).
- To celebrate Strathfield's rich cultural diversity.
- To provide input and ideas to assist Council run programs, services and facilities in as culturally sensitive way as possible (including harmony day celebrations).

#### 3.2 Eligibility

All members of the Multicultural and Diversity Advisory Committee must comply with Council's Code of Conduct and Code of Meeting Practice. Any conflicts of interest must be declared and managed in accordance with Council's Code of Conduct. Any breach may result in membership removal.

#### 3.3 Selection Criteria

To be a member of the Multicultural and Diversity Advisory Committee, applicants must meet the following requirements:

- a) Be a member of the Strathfield Local Government Area
- b) Have a good understanding of Strathfield's Multicultural and Diversity issues affecting the local community's
- c) Communicate effectively
- d) Good problem-solving skills
