That Strathfield Council writes to the new Premier and new Minister for Local Government and requests the immediate removal of the proposal to amalgamate our Council.

That Council write to Premier Gladys Berejiklian and Minister Gabrielle Upton expressing congratulations on their appointments and confirming that:

- 1. Council opposes any amalgamation of our Council and request that the current proposal be immediately withdrawn.
- 2. Council will continue to represent the Strathfield community in their unwillingness to be forcibly amalgamated as shown in the results of various recent community surveys (attached).
- 3. Council is financially viable.
- 4. Council passed all possible fit-for-the-future criteria.
- 5. Council is willing to exhaust all measures to ensure that the expressed will of its community is carried out.
- 6. Council intends to work constructively with the government on genuine reforms (i.e. not amalgamation) which serve the Strathfield community.
- 7. Council requests that the state government consider plebiscites in forcibly amalgamated councils at upcoming local government elections to determine the desire of their community for de-amalgamation.
- 8. Council extends an invitation to meet at a mutually suitable time to discuss the government's understanding of the above.
